from, they deserve the best education this province can offer. It is no coincidence - it is destiny that we rename this school in his honour on the day we open these new facilities," Maboya said.

Maboya described the renaming as a deliberate effort to embed Makgoe's values - service, integrity, courage, and humility - into the daily life of the school.

"As Julius Nyerere once reminded us: 'Education is not a way to escape poverty, it is a way of fighting it.' Dr. Makgoe understood this truth deeply. His leadership was about collective vision and achievement. Let this school embody that spirit of togetherness."

Dr. Tate Makgoe Primary houses over 1,200 learners and 35 educators, supported by parents committed to breaking the cycle of poverty through education. Appointed as MEC without formal teaching experience, Makgoe championed education for rural and informal communities, believing it to be the most powerful tool to change the world.

He also promoted mathematics and science through the Promaths initiative, partnering with Investec and the Department of Education to encourage learners from underprivileged backgrounds to excel.

Makgoe intentionally focused on areas like QwaQwa, one of the province's most impoverished towns, and provided bursaries for tertiary education to ensure public school learners received education comparable to former Model C and private schools.

The new school features state-of-the-art facilities, including administration and ablution blocks, a media centre, science and computer labs, and a hall that can seat up to 920 learners.



Dark Death Trail Haunts Centlec

entlec rocked by fresh tragedy as two senior officials die, fuelling fears of a rising death toll at the Mangaung power utility.

The back-to-back deaths have sent shockwaves through Mangaung, with insiders describing a climate of fear and uncertainty at the embattled power distributor, already under scrutiny for financial mismanagement and governance failures.

It is alleged that Centlec's health and safety manager, Mbuiselo Sarel May (51) from Grassland in Bloemspruit, was brutally gunned down in his car on Sunday.

Police confirmed that a manhunt has been launched for three suspects linked to the gruesome killing. According to spokesperson Lieutenant Colonel Thabo Covane, the trio fled on foot towards George Lubbe Street after the attack. One suspect was dressed in black with a balaclava, another in a grey or white jacket, and the third in a brown jacket.

"Witnesses reported that the deceased was shot

around 04:00 while seated in a white Toyota Vitz. He was in the company of three men when the gunfire erupted. On arrival, officers found the victim slumped behind the steering wheel with gunshot wounds to the back of his head. He was rushed to the hospital, where he was declared dead," Covane said.

May's murder follows the sudden death of his colleague, Okert (Ockie) Faber, a SCADA specialist in Network Optimization, who collapsed and died of a heart attack at his home last Thursday.

Their deaths are the latest tragedies in what many describe as Centlec's dark and unsettling death trail following the former Centlec CEO, Andries Mgoqi, who was also shot and left dying in cold right in front of his business premises, Kofifi tavern in Bergman Square, last year.

May was allegedly involved in a court case settled in May 2022, in which the defendants were held liable for R34,245.53, an amount Centlec claimed for tampering with an electricity meter box at a leased property.

The dispute dates back to May 2014, when Centlec nearly cost the utility over R23 million.

alleged that a meter box had been tampered with, potentially enabling illegal connections, and subsequently disconnected the defendant's electricity. May, who had been employed by the utility for over 14 years in various roles, presented evidence showing that Centlec had quoted the plaintiff approximately R34,000 for installing three-phase power at the rented property—a sum that was never paid.

According to the court record, a random inspection by Centlec in 2014 revealed an illegal three-phase connection, prompting the utility to remove the meter box and cut the electricity. May testified that he could not confirm who tampered with the meter box, but suggested that the tenant stood to benefit.

He also could not explain why Centlec had removed the meter box again in 2016, noting it might have been another instance of illegal connection. This testimony ultimately concluded the case in fa-

The murder of Mgoqi previously made headlines amid rumours that he was entangled in a scandal that

Sources allege that Mgoqi signed off on a deal with Vodacom after his contract had already expired, a move reportedly not sanctioned by then-board chairperson Kenosi Moroka. The execution styles of both killings have fuelled speculation that a sinister web of death is being spun around Centlec's high-ranking

Two suspects, Nkwebe Seatile and Tlotlisang Monyane, were arrested in connection with Mgoqi's murder in February 2024, while a third suspect a 41-year-old Lesotho national – was arrested two months ago. Seatile and Monyane are expected to stand trial in the Bloemfontein High Court in January 2026, while extradition proceedings for the Lesotho national are still underway.

Contacted for comment on May's killing, Centlec spokesperson Tseliso Leba declined to be drawn into the matter, citing sub judice.

"Since this incident occurred outside Centlec, the utility will leave it in the capable hands of the SAPS. We will, however, visit the bereaved family to extend our deepest condolences," said Leba.

Mystery Shrouds Mthethwa's Death in Paris

he Department of International Relations and Cooperation has confirmed the untimely passing of South African Ambassador to France, Nathi Mthethwa, who was discovered lifeless following a fall from the 22nd floor of a hotel in Paris.

French news reports indicate Mthethwa's body was found at the Hyatt Regency Paris Étoile. Mthethwa had held various governmental roles, notably serving as Police Minister from May 2009 to May 2014, and as South Africa's Ambassador to the French Republic since December 2023, tasked with strengthening the vital partnership and bilateral ties between the two nations.

"I do not doubt that his passing is not only a national loss but is also felt within the international diplomatic community," Minister of International Relations, Ronald Lamola, stated.

DIRCO confirmed that French authorities are currently investigating the ambassador's death.

Meanwhile, sources in France have reported that the incident, which might initially have appeared to be an accident, could probably be a suicide.

The first District of the Judicial Police in Paris (DPJ) has stipulated that initial investigations suggest the

act was deliberate, "without third-party intervention," according to the prosecutor's office.

This was further complicated by the fact that the South African Embassy to France was reportedly unreachable on Tuesday morning when Mthethwa's death was announced. Shocking news also revealed that Mthethwa might have left cryptic messages to his wife and a final farewell message resembling a

Mthethwa's wife had reported him missing a day prior to the discovery, claiming she last saw her husband in the afternoon as he left their Paris home to attend a cocktail party. However, the prosecutor's office confirmed that Mthethwa had booked himself into the Hyatt Hotel ten days in advance.

The prosecutor's office further detailed the sequence of events.

"That same evening, Mthethwa sent a final worrying message to his wife. He offered her his apologies and expressed his intention to end his life."

A Hyatt Hotel security guard made the gruesome discovery around 11:10 on Tuesday morning in the interior courtvard of the establishment.

The room, located on the 22nd floor, showed signs that the window's anti-opening safety mechanism had been forced with scissors left at the scene;

or narcotics were found.

Speculations have also surfaced connecting the diplomat's death to the Madlanga Commission. Mthethwa was reportedly mentioned during the commission by KwaZulu-Natal Police Commissioner, Nhlanhla Mkhwanazi, who alleged that during former Inspector-General of Intelligence, Faith

no signs of a struggle or consumption of medication Radebe, to withdraw a criminal case against former Intelligence General, Richard Mdluli. Mthethwa was allegedly on the witness list of the Madlanga Commission before his tragic death. This revelation and the suddenness of his passing have raised questions that Mthethwa could have allegedly committed suicide in fear of facing the commission, a possibility his tenure as police minister. Mthethwa had forced the Commission's spokesperson, Jeremy Michaels. refused to comment on to various media outlets.



MATJHABENG STEPS UP SERVICE DELIVERY DRIVE

Matjhabeng Local Municipality is accelerating service delivery, proudly showcasing a renewed commitment to excellence, integrity, and tangible results for its communities.

With urgency and sharper focus, the municipality has rolled out initiatives to upgrade infrastructure, streamline service provision, and directly engage residents to ensure their needs are met.

The administration says it is determined to restore hope, drive progress, and secure a brighter future for

Officials emphasise that these steps form part of a broader strategy to build trust, enhance efficiency, and create a municipality that delivers visible results.

Clean Governance and Accountability

Recent developments have reinforced Matjhabeng's reputation for integrity. The Department of Public Works cleared the municipality of any wrongdoing in the Expanded Public Works Programme (EPWP), confirming full compliance with national guidelines.

This follows Minister of Public Works and Infrastructure Dean Macpherson's investigation into allegations that EPWP funds for 2023/24 and 2024/25 were misused to inflate salaries for councillors and political office bearers.

His findings dismissed the claims, confirmed there

was no mismanagement, and ordered the release of withheld funds so projects can continue, while the municipality accounts for its support unit decision.

Lawful and Transparent Processes

The Welkom Airport project demonstrates Matjhabeng's lawful, transparent, and Council-directed approach. Beyond infrastructure, it represents a bold step to unlock underutilised land, diversify the economy, and create jobs.

Linked to the Special Economic Zone (SEZ), the Welkom Cargo Airport is being developed into a cargo and customs-controlled hub. Investors are already on site, with early inspections showing strong potential for the site to become a logistics node supporting exporters of food, fuel, and manufactured goods.

This is not a sudden shift, but part of a deliberate diversification plan. Alongside the Industrial Development Zone (IDZ) in Virginia, the airport redevelopment and other land proposals mark a consistent strategy to reposition Matjhabeng's economy and attract long-term investment.

This momentum will be showcased at the second Matjhabeng Investment Summit on 16–17 October 2025. Supported by leaders including Deputy President Paul Mashatile, Minister of Electricity and Energy Dr. Kgosientsho Ramokgopa, and Deputy Minister Pinky Kekana, the summit aims to highlight opportunities, strengthen partnerships, and inspire investor

Jagersfontein Disaster Victims Reject New Houses

ew house beneficiaries in the small Free State mining town of Jagersfontein claim that the structures built for them after the 2022 mine wall collapse disaster are not fit for occupation.

The recipients claim the new structures are too small and have been poorly constructed.

Some of the pain-points raised by them include weak window frames, flawed electricity connections, while flagging the emergence of visible cracks on the walls as some of the major safety concerns.

Joyce Tsotetsi, whose house was wiped away by the mudslide, expressed her dissatisfaction after moving into one of the new houses

"These houses are small, and some of us are cramped in there with our furniture. My previous house was not big, but it was spacious and safe. I am not happy at all, and they must come back and fix these houses," Tsotetsi told Journal News.

"My children even had to put burglars on my windows because I live alone with young children," she said.

Tseko Ntelele echoed Tsotetsi's sentiments, highlighting faulty electricity connections as his major point of

contention.
"I use candles because the new houses don't have

a proper electricity connection. I (also) take medication every day, and always have to make fire to cook, because the electricity breaker they put for me is not working."

Another disgruntled house recipient, Thabo Mosala, told Journal News that he feels the houses were hastily constructed without any prior proper planning. He also claims the house he moved into was not fully completed

"We don't feel safe living with our children in these houses because any day now they will fall on us. I even had to move my younger children," who further claimed his house was not fully completed.

The mine collapse incident is regarded as one of the worst mining-related environmental disasters in democratic South Africa.

Around six million cubic meters of contaminated waste was released into the community creating a catastrophic mudslide. Hundreds of homes were destroyed; five people lost their lives, while over 300 people were injured as a result.

According to the Kopanong Local Municipality all protocols were apparently followed to ensure that all the victims receive decent homes.

Solly Phama, the municipality's spokesperson, has attempted to allay the recipients' fears, stating that a competent housing inspector was appointed to guaran-

tee compliance during the rebuilding process.

This is despite the National Home Builders Regulatory Board (NHBRC) not coming on board to approve the structures.

"The municipality tried to involve NHBRC during the rebuilding process. However, residents were left with no choice but to return to their homes as they remained displaced, we are in interaction with the Mine to ensure that corrections are made," Phama told Journal News.

He revealed that the municipality is pursuing legal charges for infrastructure damaged by the mudslide and is in solidarity with the community, working in collaboration with sector departments to ensure compliance.

The company responsible for the mine committed R150 million as compensation to the victims. The victims were also given money to buy new household furniture to replace items lost in the mudslide.

"I received a once-off payment of R35 000, and they said they will give us another one in two years. What am I going to do with that little money, since I had a lot of furniture that was in good condition?" questioned Mosala.

"I told them that instead of them giving me the money, I can give them the receipts for my furniture, and they will buy it themselves because that money is too little, it's not even half of what my furniture was worth," he concluded.

Grannies' Welcome R10 SASSA Increase

Iderly pensioners have welcomed the R10 increase in SASSA's old-age grant, saying that while the amount is small, every bit helps in easing their daily struggles.

The South African Social Security Agency (SAS-SA) confirmed that the adjustment took effect this month, raising the old age grant from R2310 to R2320 for beneficiaries under 75, and from R2330 to R2340 for those over 75.

The increase is set to start this month in line with the announcement made by the Finance Minister, Enoch Godongwana, in the Budget Speech earlier this year.

Despite ongoing socio-economic challenges, many elderly people have expressed appreciation for the government's support.

Grace Tlatli (72) from Capestance Location in Bloemfontein said she is thankful for the increase, even as living costs continue to rise.

"We have to be grateful for everything we get. The money may be little for our daily survival, but we are able to manage," said Tlatli, who lives with her sister, a daughter, and grandchildren.

Her sister, Dorcus Kopane (74), added that their combined grants help keep the household afloat. "We are living with our unemployed daughters, each with children who are still in school, and every cent we get makes a difference in the house," she said.

SASSA confirmed the new grant amounts for the October payment cycle in a statement issued on Thursday.

"The South African Social Security Agency (SASSA) wishes to inform all social grant beneficiaries that social grant amounts will increase

in the October payment cycle. This is in line with the announcement made by the Minister of Finance earlier this year when he tabled the Budget Speech for the 2025/26 financial year," read the statement.

In tabling the Budget Speech, Godongwana announced a considerable social grant increase from 01 April 2025 and a slight increase on 01 October 2025.

The social grant amounts will be increased by R10 in October as follows:

- Old Age Grants will increase from R2310 to R2320
- Old Age Grants (older than 75 years) will
- increase from R2330 to R2340
 War Veterans Grant will increase R2330 to
- Disability Grant will increase from R2310 to R2320
- Care Dependency Grant will increase from R2310 to R2320
 SASSA CEO. Themba Matlou, welcomed the

social grant increase noting that the adjustment is crucial.

"This reaffirms government's commitment to protecting the most vulnerable in society, easing

financial burden and cushioning them against economic hardships," said Matlou. He further reiterated that it is all systems go for the October payment cycle and that all eligible social grant beneficiaries will receive their grants

without any interruption.

Social grant payments for October 2025 will be processed as follows:

- Old Age Grant will be paid on 02 October
- Disability Grants will be paid on 03 October
- Children's Grants will be paid on 06 October

Ditsobotla on the Road to Renewal

Ending months of chaos that saw two mayors, two speakers, and two municipal managers claiming office simultaneously, the council has re-elected ANC's Morutse as mayor and the EFF's Bogatsu as speaker

The re-election of Molefe Morutse as mayor of the embattled Ditsobotla Local Municipality is being hailed as the start of a turnaround aimed at restoring stability, improving service delivery, and rebuilding public trust after years of dysfunction.

His return follows national government intervention, led by former Free State Director-General Kopung Ralikontsane, to address deep-rooted governance failures, financial mismanagement, and service delivery breakdowns.

Earlier this month, the Department of Cooperative Governance ordered the election of a new mayor and speaker within 14 days.

At a Special Council sitting last week, councillors re-elected Morutse as mayor and Manana Bogatsu as Speaker. The move is intended to end months of chaos that saw two mayors, two speakers, and two municipal managers reporting for duty simultaneously.

Morutse was initially elected in March with support from ANC and EFF councillors, even as Mazwi Moruri was still holding the mayoral chain.

Ralikontsane, serving as the National Cabinet Representative, welcomed the outcome, noting councillors' "good cooperation" in consolidating leadership.
"We called this meeting to ensure that we demobilise

the two mayors and two speakers. The council supported us in finalising that process. Having a stable council will now allow us to focus on delivering sustainable services to the people of Ditsobotla," he said.

North West Premier Lazarus Mokgosi also welcomed

the election of the new mayor and speaker, describing it as a crucial step forward for the municipality.

The municipality was last month placed under administration for the ninth time.

Cooperative Governance and Traditional Affairs (COGTA) Minister Velenkosini Hlabisa confirmed the appointment of a six-member intervention team, citing the municipality's inability to fulfill its constitutional obligations to residents.

"This is the first time a team of people has come

"This is the first time a team of people has come together, bringing a range of expertise. In the past, it was one person at a time. This time, it's a team effort, and that's what gives us confidence. It's what led us to recommend an intervention to cabinet, rather than a dissolution, because never before has a team of experts stepped in to support the municipality," said Hlabisa.

During his visit to the region, Hlabisa stressed that no appointments or tenders will proceed without oversight from the national representative.

The drastic intervention, carried out under Section 139(7) of the Constitution, comes after numerous failed attempts by provincial authorities to stabilise the municipality, which serves thousands in and around Lichtenburg.

A specialised task force - including the SAPS, State Security Agency, and the National Prosecuting Authority (NPA) - will probe longstanding allegations of fraud, corruption, and misconduct.

"Cases previously ignored will be reopened. If arrests are needed, they will happen," added Hlabisa.

The municipality's senior leadership, including a municipal manager accused of mismanagement, will now face investigation, with the intervention team tasked with enforcing compliance, restoring governance, and re-establishing essential services.

Ditsobotla's collapse mirrors a national crisis in service delivery.

According to the Auditor-General, more than 80% of South Africa's 257 municipalities are financially distressed or plagued by poor governance.

FS ANCYL Demands Premier's resignation, Slams ANC Leadership

The ANC Youth League in the Free State has issued an audacious call for Premier MaQueen Letsoha-Mathae and her entire cabinet to resign immediately accusing them of failing the province and its

This demand was part of a series of resolutions adopted during the league's three-day Provincial Executive Committee (PEC), which took place in Welkom over the weekend.

The league said this in a media statement released on Thursday afternoon.

The league also urged the ANC's National Executive Committee (NEC) to disband the ANC provincial leadership accusing them of suffocating the movement with mediocrity, timidity, and contempt for the youth.

"The ANCYL declares without hesitation that Letsoha-Mathae must resign. She has failed the youth, failed the province, and trampled upon the principles of consultation and accountability.

"She presides over collapse, corruption, and decay. She is dishonest, incapable, illegitimate, and unfit to govern. She is the enemy of youth and an enemy of the people, said the spokesperson Sinazo Hafula in the media statement.

The league further announced that they have also resolved to register a motion of no confidence against the PEC saying that they are acting like irresponsible parents who almost a year later after their provincial congress still have not met with the elected leadership of the youth league.

"They carry themselves as though the youth league is an afterthought despite repeated attempts by the league to secure a meeting, she said.

Although the ANCYL later issued a second statement distancing itself from the initial release, Hafula confirmed in an exclusive interview with Journal News that the contents of the first letter reflect the resolutions that were passed at the PEC meeting.

"Yes we did write the letter, but it was leaked by someone in our PEC before it could be approved for release to the media, she said.

When asked if she would like to explain the confusion, she declined and said she is not at liberty to disclose the dynamics yet.

Some of the resolutions that were taken at the meeting are that the PEC rejects the propaganda that the state is broke and said that South Africa has one of the strongest public balance sheets in the developing world

"The crisis is not a lack of resources but it is deliberate sabotage to protect financial capital.

"Over two hundred billion rand sits idle in govern-

ment reserves while schools lack textbooks and clinics are running out of medicine, said the statement.

The meeting also concluded with the disbandment of

the Xhariep ANCYL region.

Hauweng Bus Commuters Hit by Fare Hike

s of Wednesday, Mangaung Transit's Hauweng bus commuters were forced to dig deeper in their pockets following the municipality's implementation of new travel tariffs.

The Mangaung Metro municipality has announced a 2% hike in Hauweng bus fares, citing escalating operational and service costs.

In a notice issued last week, the City said bus fares are reviewed annually in July as part of the municipal budget process. This year's increase, approved by Council, is the first annual fare adjustment for the Hauweng Bus Service operating along the Brandwag corridor.

According to the municipality, single-trip tickets have risen from R10 to R12, return-trip tickets from R20 to R24, while multi-journey tickets now cost R120, up from R100.

"This increase is justified as a measure to balance escalating operational and service costs

while keeping fares affordable for users to ensure long-term sustainability of the project and revenue collection for the City," the notice read.

Launched in July 2024 after years of delays since its 2016 inception, the Hauweng Bus Service has faced controversies and allegations of mismanagement. It currently operates on Phase 1C along the Brandwag route.

In his State of the City Address last week, Mayor Gregory Nthatisi said phases 1A and 1B of the project will soon be rolled out, extending services to the Moshoeshoe and OR Tambo routes. These expansions will be supported by the Public Transport Network Grant (PTNG).

The municipality reminded commuters that tickets do not expire and encouraged frequent users to buy the 10-trip multi-journey ticket for convenience and weekly budgeting.

The City maintains it is committed to providing an affordable, reliable, and safe transport system for Mangaung residents.

Jobs Bloodbath: 80,000 Jobs vanish nationwide

outh Africa's labour market has taken a heavy knock, with Stats SA reporting a 0.8% drop in total employment, amounting to 80,000 jobs lost in just three months.

The latest Quarterly Employment Statistics (QES) show that job losses were most pronounced in the trade, manufacturing and construction sectors, raising concerns of deepening strain on an already fragile economy.

The latest data from Stats SA's Quarterly Employment Survey (QES) shows that formal employment in the country is under severe strain, particularly in the community services sector.

Total employment decreased by 80,000 or 0.8% quarter-on-quarter, from 10,589,000 in March 2025 to 10.509.000 in June 2025.

This was largely due to a decrease in the following industries: community services (-53,000), trade (-10,000), manufacturing (-9,000), construction (-7,000), transport (-2,000) and business services

However, there was an increase in mining (+2,000) and electricity (+1,000).

Total employment decreased by 229,000 or 2.1% year-on-year between June 2024 and June 2025, down from 10,738,000 last year.

Year-on-year job losses were mostly recorded in community services (-225,000), followed by manufacturing (-18,000), mining (-6,000), transport (-3,000) and trade (-1,000).

Job gains year-on-year were recorded in electricity (+1,000) and business services (+23,000), with a flat result for construction.

The QES is an employer survey that tracks the number of formal jobs in the country, excluding agriculture, hunting, forestry and fishing and private households.

This differs from the Quarterly Labour Force Survev (QLFS), which is a broader household survey that captures various employment types, including informal and domestic work, and unpaid family workers.

The QES gauges the health of South Africa's formal business environment, while the QLFS focuses on the labour side, and is used to determine the official

That said, the QLFS for the second quarter of the year also recorded a 140,000 more workers becoming unemployed in the quarter, with the official unemployment rate ticking up to 33.2%.

Both data sets point to a deepening jobs crisis in the country, with the QES in particular pointing to a worring trend, marking the third consecutive quarter

of declining numbers. Prospects for the remaining quarters of the year are also dim, with South African businesses facing increasing risks due to internal and external pressures

on the economy. While thousands of jobs were lost over the quarter, those who remained employed and on payrolls

would have seen higher earnings. TheQES overs eight key industries or sectors in South Africa, which is split further into 20 sub-categories, mainly made up of various manufacturing

sectors, as well as a split between government and non-government community and social services. The average monthly earnings paid to employees increased by 3.4% from R28,322 in February 2025 to

R29,290 in May 2025. Year-on-year average monthly earnings paid to

employees increased by 6.5% between May 2024 and May 2025, Stats SA noted.

Gross earnings increased by R2.2 billion or 0.2% from R984.7 billion in March 2025 to R986.8 billion in June 2025.

This was largely due to an increases in community services, trade, construction, transport, mining, electricity and manufacturing—despite the jobs shed.

However, there was a decrease in earnings the business services industry. Basic salary/wages increased by 2.5% over the

quarter, while bonuses decreased by 25.4%. This reflects the expected change in seasonal bonus pay. Overtime, however, also declined by 1.0% over the

Year-on-year, basic earnings paid increase by 3.6%, in line with inflation, while bonuses paid increased by 5.1% versus the same time last year. Overtime paid decreased by 4.5%.

UFS Caught in 'Bogus' Qualification Row

quiet crisis is unfolding at the University of Free State School of Nursing with about 50 **I**post graduate students trapped and stuck with "fake" qualifications.

The class of 2023 Postgraduate Diploma in Occupational Health Nursing and the Postgraduate Diploma in Primary Care Nursing at the UFS nursing school who attended a year long programme with the hopes and aspirations of improving their lives and careers have turned into a nightmare as their qualifications are not valid to be registered by the South African Nursing Council.

After graduating the students received the shock of their lives when SANC declined to register their qualifications saying that their diplomas are invalid.

SANC is the official body responsible for setting and maintaining high standards for nursing education and practice across South Africa, if not regis-

tered, nurses may not practice. Their dreams were shattered when they received an email from the school on 13 December 2023 stating that there is a delay in the registration process due to pending matters with SANC concerning their status as learners.

According to SON, the OHN and PHC programmes were only registered by the Higher Education and South African Qualifications Authority (SAQA) before

A professional nurse in private sector and one of the Nursing students, Karabo Tlhatlogi explained that in 2022 the UFS advertised then post graduate diploma programmes in Primary Care Nursing, Occupational Health and Nursing Education.

He says these programmes were listed on the SANC website as accredited offerings, but at onstage during the registration of their studies were they informed that the programme was not fully accredited. "This lack of transparency denied us the right to make informed decisions about our education and professional futures.

"Despite numerous attempts to engage with the school of nursing, our concerns have been met with silence, delay and inadequate responses. While oth-

er students from other cohorts have been registered and employed, our applications remain unresolved. Journal news is in possession of all the letters that

were sent to students about the matter since 2023, and the message is that the the nursing school is still trying to resolve the matter. The first letter dated 13 December 2023 from

Programme Director Dr LJ Magakwe " ... There may be some delays with the registration of your additional qualification at SANC due to challenges that were experienced during your registration and n as

The second letter dated 02 May 2024 from nursing school head Dr Jeanette Sebaeng ".....The two programmes commenced on conditional accreditation..." Third letter dated 10 October 2024 from Seabeng "....No formal feedback has been received yet...." Fourth letter dated 20 March 2025 from Seabeng "...SANC only accredited this qualification in the cause of 2023, meaning this qualification was not registered by SANC at the time UFS registered students in this programme at the start of 2023..."

The same letter was sent again in November 2024 by Seabeng The final letter dated19 September 2025 from UFS spokesperson Lacea Loader "....UFS received feedback from appeals panel of SANC....we will inform you soon of our response to the feedback from the appeals panel...."

These students have expressed their frustration saying that they feel betrayed by the University for giving them a qualification that they cannot use, and it has become a nightmare.

Tlhatlogi says this has been a stressful and depressing experience.

He says he has invested money, time an effort to do his postgraduate on Occupational Health and now 18 months later he is unable to be a specialist in his nursing career.

"We have been fighting this matter, but we are not getting a clear message. All we are getting from then university is that they are in talks with SANC.

"When we contact SANC, they say that the issue is not within SANC's scope to resolve and directed the matter back to the university, which added further confusion and concern to us.

"Eighteen months after completing our qualification, we remain unregistered with SANC, leaving us professionally stranded.

Tlhatlogi says he has missed four opportunities as a nursing specialist, but he cannot get the promotion because his qualification is not recognised.

Samantha Drury from the Eastern Cape studied a Postgraduate Diploma in Primary Care Nursing. She said that she enrolled in this qualification

to empower herself and upgrade her salary, as her current salary is not enough.

"I am stagnant in a facility that I do not want to work in because I had an agreement with HR that I would take a transfer to a closer facility after graduating, because they had a vacant post which needed this Primary Care Nursing qualification, now 18 months later, I'm stuck in this facility as a general nurse," she said. "I spend triple the petrol I used to because I had an injury on duty after being assaulted by a patient, thus we had the agreement with my HR department that I'd move to one of the two facilities next to my home because my sight was reduced

She says going to work is a nightmare and that she is on depression medication because of this whole

"I have never felt so betrayed in my life. I was handed over to attorneys for fees of a qualification that is invalid.

"I will never recommend anyone to go to UFS, to think this was one of the reputable universities" Another occupational health student, Azola Nyamfu says she is tired and emotional.

She says that this year alone, she had three offers from three occupational health clinics but was turned down after disclosing that she didn't have SANC documents.

Due to frustration, the group even approached the UFS Law Department in June 2024 with requests for assistance in resolving the matter, but no effective support or resolution was offered.

Journal News approached Loader about this matter and she explained that the university is commit-

ted to finding an amicable solution. "The university is engaging relevant stakeholders, including the South African Nursing Council (SANC), and will liaise with the students imminently regarding the professional registration of their Postgraduate Diploma in Occupational Health Nursing and the Postgraduate Diploma in Primary Care Nursing which they completed in 2023.

"The UFS recognises that this has been a lengthy process and remains committed to finding an amicable solution, said Loader.

Maleka is unemployed and lives with her three children. They all rely on the South Africa Social Security Agency (SASSA) grant.

"I feel so happy. I could jump on top of my roof and scream with excitement. I am very grateful to our government, she said.

Another beneficiary is Catherine Monareng (65), who has been living in her house since 2010.

She is blind and unemployed and lives with his son. They rely on the disability SASSA grant.

"I am happy because my title deed was delivered by the minister herself.

This is proof that the house indeed belongs to me, Monareng said.

Hlalele Declares War on GBV in 90-Day Campaign

ree State MEC for Social Development, ■ Mathabo Hlalele, has vowed to confront Gender-Based Violence and Femicide (GBVF) head-on, launching a bold 90-day campaign to tackle what she described as a scourge terrorising communities.

Addressing residents, Hlalele warned that GBV had reached crisis levels, with women and children bearing the brunt of relentless abuse. She stressed that silence was no longer an option in the face of rising femicide cases.

She said the programme was designed to confront the apartheid legacy of broken family structures caused by the migrant labour system.

"A special JCPS Ministerial meeting reflected on the magnitude of GBV in South Africa and reaffirmed government's strategic posture in dealing with it through increased communication, awareness, and community mobilisation," Hlalele said. "Despite the President's declarations, the country continues to see an unprecedented rise in brutal violence against women and children in our province, with Mangaung Metro identified as a hotspot — recording 504

Hlalele painted a grim picture, citing the killing of 19-year-old Puleng Motlodi of Thaba Nchu, whose body was dumped in a pit latrine. "From deep inside her grave, Machaka Radebe is crying out against Gender-Based Violence, which stole her precious life. So too are Mpho Moalusi, Olorota Mongalo, Bongiwe Phulampa, and countless others. These poor women lost their lives because some cowards believed they had the power to decide their fate," she said.

An urgent meeting of the Justice, Crime Prevention and Security (JCPS) Cluster in April culminated in the adoption of a 90-day acceleration programme to intensify the national response and fast-track implementation of the National Strategic Plan on GBVF.

According to the latest police crime statistics, the Free State has seen spikes in rape, attempted murder, sexual assault, and assault with intent to cause grievous bodily harm between October and December last year. Attempted

murder cases rose by 9.3%, while sexual assault increased by 4.4%.

Thabong Police Station in Welkom remains one of the province's biggest hotspots.

The Drivers of Change in Education for Deaf Children

eptember was the International Month for Deaf People. The World Federation of the Deaf declared September as Deaf Awareness

The aim of this month is to promote the positive aspects of deafness, as well as social inclusion. As a hearing parent I had little to no tools to help me navigate deafness in my child and ultimately the Deaf community and culture.

I struggled to find my feet and make the choices that would be best for my child's future. I simply did what I could and what health practitioners had hurriedly told me to do.

I lacked support and access to parents who had been through the same thing or just a space where I could share my journey with people that would enlighten me further than the health practitioners had. Eventually my son entered school, though he thrived with his sign language and his deaf identity formation, the schooling environment itself was simply not a comfort to me.

I experienced various challenges and though I finally met parents who could relate to my journey I was quickly disappointed at the level of a positive school experience the learners have.

Their reading and writing development were extremely underdeveloped and they struggled to keep up, even those in higher grades than my son.

The importance of encouraging reading The South African segment of the Progress in International Reading Literacy Study 2021 (PIRLS 2021), conducted by the University of Pretoria, reveals a concerning statistic: 81% of South African Grade 4 learners struggle with reading comprehension at the age of 10.

This issue is exacerbated among children with learning challenges, particularly Deaf children. Research indicates that only one in three Deaf adults proficient in South African Sign Language (SASL)



are functionally literate, and the average literacy level of Deaf school leavers corresponds to that of an eight-year-old hearing child.

Contributing factors to these challenges include a lack of a reading culture, insufficiently resourced educational institutions, and inadequate emphasis on early childhood development.

Finding solutions

I had multiple engagement with the stakeholders in the inclusive education space, including the Department of Basic Education (DBE) as well as the school for the Deaf.

However, I eventually realised the only solution might need to come from us as parents.

I wrote a proposal and consulted possible par-

ties, the University of the Free State (UFS) library, as well as the UFS Department of South African Sign Language and Deaf Studies both heard my cry and this project was supported.

We formed a project called the HEARTS project. It is not an acronym, but simply means the children are the heartbeat of the project and everyone involved has taken their roles wholeheartedly. Parents in the project get SASL training and support each other in navigating parenting and educating their deaf children.

The children get extra reading classes, where we support their development through a positive reading culture and reading for fun activities.

In the short time that we have had this project

both parents and schoolteachers have seen a difference in this small group of children.

The HEARTS project is close to the people involved, purpose driven and valuable to each individual no matter how they've contributed and gained from the project.

We hope more parents and children can benefit from this over the years, but our greatest hope is to create a world where being deaf does not equate to a second-class education, where inclusivity doesn't look like marginalisation and isolation. It is important to note that this project cannot be successful without the commitment of all parents ensuring that the work is done beyond the classroom, incorporating a reading culture at home and improving their sign language skills through constant communication and engagement with

We see this initiative as a small start to what we hope will be a bigger project, one where parents can get support as soon as their child is diagnosed. To understand fully their non-medical options before they make big decisions.

We would like to see more schooling opportunities closer to home.

For the DBE to foster true inclusivity, and encourage not only academic success, but sports and arts and culture as avenues for success.

We hope for a schooling system that recognises the Deaf's need for empowerment, a school that sees them as future contributors to the economy and leadership of the country, a schooling system that doesn't create limitations but ensures extended possibilities.

outh African actress and fashion designer Enhle Mbali loosely used the K-word to describe her hair in a room full of white people during a brand partnership launch of the renowned hair brand Carlton Hair.

Quoting her verbatim Enhle said, "I am the only one allowed to use this word, I have k**fir Hare and black people know what I mean, colored people know what I mean.

For some reason, everybody in that room laughed and downplayed the insensitivity of the word making it seem like it's okay to use that word.

Hi, everyone, my name is Refilwe Mochoari, let's talk about the legal implications of using the K-word in South Africa and why black people in general think it's okay for them to use the word when the South African historical background has such bad memories of the usage of this word.

Is it acceptable for black people to use the K-word but white people are not allowed to use it?

Not so long ago, Minister of Sport Art and Culture Gayton McKenzie used the K-word during a live video and some of his social media posts which were published between 2011 and 2017.

The minister also did not see anything wrong with using the word or rather he denied ever using the word.

The minister faced some social media slurs with many saying that he should be removed from his position as minister.

K**fir is a word that was commonly used in the eighteenth and nineteenth centuries as a non-pejorative reference to black people.

During the apartheid era, this word acquired powerful, negative connotations with not only the black community but also across the racial spectrum.

This word is widely recognised as inherently racist and unequivocally unlawful.

The usage is viewed as a deliberate act of inflicting harm, impairing dignity, and causing humiliation to black South Africans.

In 1996, the South African constitution adopted this when South Africa gained democracy the K-word was criminalized because of the historic background of the Apartheid era where the word was used as an insult to black people when they were killed, abused, and tormented by the apartheid government.

The fact remains, usage of the K-word will always be referred to as hate speech no matter what the skin color of the perpetrator looks like.

As South Africans we have been taught that this word may not be used by anyone or else there are some consequences to be faced.

Now Entle has found herself in hot water after she referred to her hair type as being "K**fir Hare" She said this during her welcome speech at the launch event and this has resulted in an uproar from social media followers criticizing her for her language usage.

Both Enhle and Carlton posted their speech but after the social media heat, the videos were removed.

Why did they remove them?

Enhle was announced brand ambassador for Carltons Hair's new black hair range, but that did not last long because now thensame the company has paused all related promotional content which features her and are conducting a full review of their partnership guidelines to ensure that alignment their inclusivity standards, adding that they will prioritise collaborations with voices that authentically amplify empowerment and cultural pride

She also issued an apology stating that she spoke in the language terminology that is commonly used where

Why would Enhle use the word in such a public platform? Does she know that the word is categorized as hate speech?

But apart from Enhle, how many other people of color use the word as loosely as Enhle did?

Now what irks me the most is how loosely black people generally use the word. How does Enhle think that it is okay to use the word just because she is black?

How did everyone in that room who laughed though that this is funny?

The word was created with malicious intent, but why do black people think it's okay to use the word? This is a word that was used to kill our forefathers during the These are the kinds of jokes that must never be ac-

cepted, never accept any derogatory speech as a joke.

If we were to turn the tables and a white person said what Enhle said, would that then show how insensitive it is to use the word?

Transformation Begins With What We See and Hear

o many of us wish to transform our lives and live our dreams. But despite our best intentions, many of us will also trip ourselves up along the way. Why? Because we haven't been intentional around two crucial aspects: what we see, and what we hear.

By deliberately choosing what we see, we influence our mindset and, by extension, our reality. Similarly, what we choose to hear regularly conditions our minds to believe and act on those messages. Consider the following:

* 82% of small business owners who used vision boards from the beginning succeeded in more than half of their stated goals (TD Bank, 2016).

* Children who frequently watched violent TV shows between the ages of 6 and 10 were more likely to exhibit aggressive and violent behaviors in young adulthood (Huesmann, L. R., Moise-Titus, J., Podolski, C.-L., & Eron, L. D., 2003).

Simply put, what goes into our minds often comes out as life experiences — some good, some

not so good. By developing the practice of intentional attention around what we see and hear, we set the stage for the next steps in our leadership evolution, enabling our goals, dreams, and visions to become reality, and driving our journey toward personal and professional success.

As an Executive Mentor who has worked with CEOs and other high-performing professionals, I can assure you that being intentional about what you see and what you hear is essential for making powerful shifts in your life. In fact, they are the first two steps — and potentially the two most important ones — the SHIFTS process model:

* See: You are the sum of what you repeatedly

* Hear: You are the sum of what you repeatedly

* Insight: Your insights and feelings anchor your beliefs about yourself and the world.

* Formulate: Your belief system Formulates your decisions and creates habits.

* Transform: Your decisions Transform your actions for making those big, bold moves!

* Succeed: Your actions lead to Success. I have learned about this model at length in Sam's book "SHIFTS: 6 Steps to Transform Your Mindset and Elevate Your Leadership," and I teach it to our church and our leadership community at the Empowerment Leadership Summit. I'm proud to say that more than 5,000 leaders have attended and been impacted since its inception in 2013. I truly believe that if the SHIFTS model was taught in more educational institutions, many more of our young people would be empowered to make stronger choices, pursue more positive paths, and set more ambitious goals - not only for them-

At the heart of the SHIFTS model is self-leadership and self-mastery. You cannot lead others until you desire to make SHIFTS in your own mind and choose to lead yourself first. And the first step towards doing so is becoming intentional about what you consume visually and auditorily.

selves as individuals, but for their communities,

countries, and our planet as well.

So that begs the question: What will you consume? Will you read a book by a successful entrepreneur, civic leader, teacher, or prophet? Or will you doom scroll on social media? Will you listen to music that inspires your soul? Or will you tune into the latest celebrity gossip? What we consume

makes us who we are. Or, as I once saw written on a banner at a booksellers convention: What goes into a mind comes out in a life.

Ideas for Curating What You See and Hear * Books: When I set out to transform my life from the inside out, books became an invaluable part of my journey — and they still are! Books are one of humanity's greatest inventions — if not the best — as they provide a hand-held vehicle for absorbing others' wisdom. A book is an easy way to transport you directly into the mindset of some of history's greatest statesmen, philosophers, entrepreneurs, athletes, and academics. Books, therefore — whether physical copies, e-books, or

audiobooks — are always a wise investment. And let's not be mistaken: Books are not simply for beginners — they're for the über-successful as well! Billionaire Warren Buffett spends about 80% of his day reading: "Read 500 pages like this every day. "That's how knowledge works. It builds up, like compound interest".

* TV & Films: Movies shape our minds, whether we realize it or not! My daughter once had a friend from overseas who spoke English fluently. When asked how she became so proficient, she stated that she had become adept by watching American movies! Similarly, a study by de Leeuw, R. N. H. & van der Laan, C. A. (2018) showed that when children were shown a film clip in which the main character helped another character, the children modeled the behavior.

How are the movies, TV programs, and documentaries you're watching influencing you? Which ones have caused stress, anxiety, or questionable behavior? Which ones cause your heart to soar and expand your ability to feel hope, love and grati-

rapper, singer, and activist Emmanuel Jal once said: "Music — it's the only thing that can enter your system, your mind, your heart, without your permission." We each know that music can both make us feel happier, as well as incite dark and aggressive thoughts. Based on where you want to

* Music: The South Sudanese-Canadian actor,

go in life, which music will you use as your mental and emotional fuel?

Take some time to write down your life's playlist. Some of our favorite songs and pieces of music come and go with time, but others have longevity in our lives. Which songs shift your mood when you're down? What music reminds you of your best attributes?

But when making SHIFTS in our lives, of greater importance than education is the practical application of what we learn. Yes, knowledge is power, but competency

* Association: The people we associate with the ones in our immediate orbit — influence us the most. Why? Because they're the ones we see and hear the most! The company we keep will propel our SHIFTS or sink them — it's that simple. Of course, we should never callously sever bonds, but at the same time, elevating our leadership and making SHIFTS in our lives sometimes calls for making difficult choices. Always remember the following quote, often attributed to motivational speaker Jim Rohn: "You are the average of the five people you spend the most time with."

* Exposure: The human mind is much like a camera — your eyes the aperture, your memory the film. My family and I once took a trip to Athens and Milan, knowing that what we were to see and hear in those beautiful places was to stay with us and SHIFT our minds for a lifetime. Depending on your circumstances, consider investing in inspiring locales, regions, and environments — even if they're only a few miles away.

Doing so helps create a vision of what is yet to

Rooted in Resilience: **Nkhoke's Organic Empire Blooms**

he first light of dawn spills across the fields of Ladybrand, a quiet Free State town where Lydia Nkhoke's story begins.

What seemed like a family setback — her mother, Maria Nkhoke, breaking her leg while managing the Mantsopa Mothers Agricultural Primary Co-operative Limited along with other family ventures — became a

Stepping in to help, Lydia discovered both her passion and talent for agriculture, planting the seeds of what would grow into her own organic farming empire.

It was a far cry from the woman who, just a few years ago, would have hesitated at the touch of damp soil seeing only dirt where she now sees life and possibility.

The turning point came with what the Nkhoke family first saw as a crisis. Lydia's mother, Maria, broke her leg while running the family cooperative.

To keep things afloat, Lydia made a life-changing decision: she resigned from her administrative clerk position at the South African Social Security Agency (SASSA), a job she had held for nearly two decades, and stepped into the world of farming.

The Mantsopa Mothers Agricultural Primary Co-operative, founded by Maria in 2002, had secured 60 hectares of land from the Mantsopa Local Municipality the following year. Slowly but surely, through applications for funding and sheer persistence, the cooperative began to grow.

vincial awards and even travelled across Africa, sharing in what Lydia describes as an "agricultural awakening."

Today, the cooperative's fields flourish with spinach, tomatoes, carrots, green peppers, beans, and pota-

Their fresh produce makes its way to major retailers such as Cambridge, Fruit & Veg, and Spar, as well as to school feeding schemes and local communities. Loyal clients - including the Department of Education praise both the quality of the produce and the reliable

"I never thought agriculture would mean so much to me. I had no passion for it." Lydia admits, "but it opened doors and gave me a new perspective on the

The cooperative now employs six full-time workers - four men and two women - with hopes of expanding the team as the business grows.

Their efforts have also caught the attention of the

Premier Maqueen Letsoha-Mathae praised Nkhoke's leadership, saying: "We are committed to supporting people like Mme Nkhoke. They are equipped with knowledge and passion for agriculture, and we are going to ensure that they are empowered, but most importantly, supported in their growth."

For Lydia, however, the vision extends beyond farming success. She dreams of turning the cooperative into a skills hub for young people.

"I want this to raise awareness, especially among the youth, that there are endless opportunities in agriculture. They shouldn't overlook it," she explains.

Already, she has taken her message into detention facilities, offering agricultural advisory services and skills development programmes.

The woman who once preferred concrete now finds her grounding in the soil - her passion growing as steadily and surely as the crops she tends.

Police Seize Counterfeit Goods Worth R260m in North West

olice in the North West have seized counterfeit goods worth R260 million. This was done through the police's operation aimed at dismantling the illegal trade in counterfeit and illicit goods across the country.

The integrated operations were led by the National Counterfeit and Illicit Goods Unit, in collaboration with Public Order Policing and Crime Prevention Units in the Province, and other role players such as SARS Customs Division and brand protec-

Police say more than 100 shops in and around Coligny, Klerksdorp, Lichtenburg, Mafikeng, Potchefstroom, Rustenburg, Ventersdorp, and Zeerust were identified and targeted during the operation. That is where they confiscated over 86 000 counterfeit items that include designer-branded clothing, sports apparel, footwear, bags, caps, toys, and consumables

Police also confiscated counterfeit medicines valued at more than R45 000, along with illicit cigarettes and liquor.

Originally scheduled for August, organisers have announced that it will now happen in December with no exact date announced and now it has been cancelled.

NAC Opens Arts Stimulus Fund – Up to R800k for Projects

The National Arts Council of South Africa (NAC) has officially opened applications for its 6th Presidential Employment Stimulus Program, inviting individual arts practitioners, registered arts organizations, companies, and community art centres to apply.

Applications close on 9 October 2025, with outcomes set to be announced on 1 December 2025.

The program is aimed at creating jobs in the arts, heritage, and cultural sectors, while stimulating the economy and driving sustainable development. It places emphasis on youth participation, inclusion of vulnerable groups, capacity building, and broad community impact through audience development and national reach.

Eligible projects include workshops, exhibitions, showcases, performances, and arts training initiatives. Proposals are expected to demonstrate strong community value and sustainability.

Funding allocations will vary: major projects may receive up to R800 000, medium-scale projects up to R500 000, and smaller initiatives R300 000 or less.



SAFA pressured to Fire Tseka

he journey of the South African national football team, Bafana Bafana's qualification towards the prestigious 2026 FIFA World Cup in North America, has been thrown into disarray not by the prowess of an opponent, but by a catastrophic failure of internal administrative duty.

The crisis, which threatens to invalidate hardfought victories is now centred squarely on the office of the team manager, Vincent Tseka – whom the South African Football Association is being pressured to dismiss in effectively dealing with this mammoth

Tseka has been specifically identified as the primary individual responsible for the oversight involving the suspension of key midfielder Teboho Mokoena. This error initiated a formal process that saw South Africa officially being docked points in the fiercely contested 2026 FIFA World Cup Qualifiers campaign, drastically compromising the team's standing and prospects of going to the global showpiece.

As team manager, Tseka's role is considered the linchpin of the national team's operational structure, and therefore requires immaculate attention to detail, precision, and proactive communication. His responsibilities encompass the vital duty of tracking and instantly informing the entire technical staff. including the head coach and his assistants, of any disciplinary rulings or player suspensions that could render an athlete ineligible for selection in an upcom-

Tseka further serves as the indispensable link be-

tween all internal departments and external parties, dictating that all crucial, non-playing information is reported directly to him. Therefore, the eligibility of any player is arguably the single most critical piece of pre-match documentation.

Tseka should have been the one to provide this non-negotiable warning to the technical team well in advance of the crucial match against Lesotho in

whopping R1.2 million is up for grabs at the inaugural Diamonds and Dorings Kimberly Big Hole Marathon launched on Monday at the Mittah Sperepere Convention Centre by Northern Cape Premier Zamani Saul.

The marathon is set to take place on 22 November and will feature several race categories, 5km, 10km, 21,1km, and 42,2km.

The Northern Cape Provincial Government, in collaboration with the Athletics Griqualand West Federation has come into partnership to form the second largest marathon in the country after the Comrades marathon.

Speaking at the launch, Saul, said that it is not a coincidence that the marathon is launched a day

before the end of Heritage Month.

"Sports has a unique ability to transcend our cultural, racial, and linguistic differences. It gives us a sense of belonging while serving as a common

"The only time you can see how united South Africans are is at a sports event, this is the only time we assert our South African-ness and forget about any other second identity," said Saul.

He said sports play a critical role in unifying the nation because it fosters cohesion, peace, and development which contributes to creating a vibrant heritage.

He also said the Diamonds and Dorings Kimberly Big Hole Marathon passes some of the iconic sites in Kimberly, which speaks to the province's heritage. Also attending the launch was Executive Mayor of the Sol Plaatjie Municipality, Martha Bartlett, who said that the marathon is not just about kilometers and medals, but it is a celebration of the resilience of the heritage of a community and progress.

"From the 5km fun run to the grueling 42,2km marathon, every stride taken on this route will tell the story of our province's commitment to health and development," she said.

Amongst other guests was the President of Athletics South Africa, James Moloi who said that they will be there to support runners.

"I wish this could be an annual race, but we will do our best as the ASA to give our support, and we will also bring some of our top athletes.

" I would also like to give assurance that maybe after next year, this race will be a South African championship," he said.

Moloi said South Africa has 1.8 million registered athletes and that it shows that the country has support for good health.

The runners who will receive payments are those who will come in positions one to ten

For the 42km both male and female will win R200 000 each. For 21.1km both male and female will receive R50 000, for 10km winners will receive R10 000, and for 5km winners will receive R5000

Registration for all four categories, 5km, 10km, 21,1km, and 42,2km, opened on 1 October.

The starting point will be at Sol Plaatjie University and passing landmarks such as the Monument of the Dead, the Oppenheimer Garden, and the Northern Cape Legislature, among others. The finish line will be at the university's sports ground.
