### Moqhaka MM Faces Imminent Arrest

The Municipal Manager of Moqhaka Local Municipality, Portia Tshabalala, is reportedly facing imminent arrest following serious allegations of financial misconduct involving more than R221 million unlawfully paid to a security company that allegedly did not qualify for the tender.

Law enforcement agencies are said to be finalising the case, with an arrest expected soon as investigations have been completed.

This development follows President Cyril Ramaphosa's signing of Proclamation 163 of 2024 in April last year, authorising the Special Investigating Unit (SIU) to probe the Moqhaka Municipality's contracting of Isidingo Security Services.

According to a confidential referral affidavit dated September 2025, which contains the full SIU investigation report and is in the possession of Journal News, Tshabalala unlawfully appointed Isidingo Security Services, a KwaZulu-Natal-based company, that allegedly failed to deliver the physical armed security services for which it tendered.

The municipality ultimately paid the security company more than R221 million Continues on Page 2



## MaQueen Commits to **Combat Corruption**

remier MaQueen Letsoha-Mathae has reaffirmed her commitment to tackle corruption in the Free State by uprooting it in all levels of employment in government.

In an interview with lifestyle magazine, Ignited Woman, Letsoha-Mathae declared that her administration will not focus on exclusively eradicating corruption at senior levels of government, but also expand it to junior employees who are involved in government procurement procedures.

"If they think I am coming for senior managers, I am even coming for those clerks who are requesting quotations. Today I am dealing with one department, I am moving one person from the other department to the other, even HODs," said Letsoha-Mathae.

She also hinted at the possibility of scrupulously rotating government staff to remove them from their comfort zones, where they can casually be tempted to take part in illicit procurement practises.

Said Letsoha-Mathae: "This is what we are going to do as the province...you can't say you are going to change the lives of the people (and) empower the Free Staters, when the same supply chain managers are the ones in the same positions."

The Premier further queried why service provider from outside where being prioritised in lieu of local businesspersons.

She firmly stated that the latter approach is flawed, highlighting abhorrent incidents that are being perpetrated in other provinces, where bidders some-

times find themselves being at the mercy of gun-toting assailants during tender briefing sessions.

"I want to tell you seated here that what is happening in other provinces, when there is a briefing session and people just come in with guns and say: those who are not from here (get) out. We must address that before we reach that stage."

"Let us address this issue and empower the people of the Free state," stated Letsoha-Mathae.

The Free State has indeed not been spared in the nationwide scourge of procurement corruption. According to the 2023/2024 financial year annual report from the office of the Premier, in March 2022, a service provider was appointed to investigate irregular, fruitless, and wasteful expenditure identified by the Auditor General of South Africa (AGSA) during the financial years 2017/18, 2018/19, and 2019/20. In this investigation, 144 audit findings were related to irregular, fruitless, and wasteful expenditure; 25 of them were finalised and acknowledged by the accounting officer on 25 May 2023.

It was through this investigation that additional irregular expenditure was discovered to have been incurred during 2017/18, 2018/19, and 2019/20. amounting to R28 768 000. By 31 March 2024, 49 more investigations were finalised, but not acknowledged by the accounting officer.

Excerpts from the report read: "The disciplinary recommendations contained within these investigation reports have not been implemented, as required by PFMA 38(1)(h)(iii). Management expects that the remaining investigations will be completed by 31

March 2025."

The report indicated that no independent service provider was appointed to investigate instances of irregular and fruitless, and wasteful expenditure incurred during the period 2021 to 2023 and further states that no internal investigations have been per-

formed by management to determine if disciplinary steps need to be taken against liable officials," the report mentioned.

Noting that Letsoha-Mathe only assumed her duties as Premier in June 2024, the annual report covering her tenure as Premier is vet to be released.

over three years for a tender originally valued at R87 million. This expenditure exceeded the contract value by 66%, significantly higher than the 15% provision allowed for in the municipality's 2018/2019 supply chain management policy.

Journal News has been reliably informed that the Special Investigating Unit (SIU) has submitted its report to the National Prosecuting Authority (NPA), recommending criminal prosecution against Tsha-

"The matter has been handed over to the NPA for prosecution. I can confirm that the NPA is currently in possession of the report, and the arrest of the Municipal Manager can be expected soon," said a source close to the investigation.

The SIU report has flagged several irregularities in the appointment and management of the contract. Key findings include that Isidingo Security Services' firearm licence had already expired at the time of appointment on January 17, 2020, this means they couldn't legally deliver the required armed security.

Furthermore, as a Durban-based company, Isidingo didn't meet the requirement for locality prefer-

The SIU report also highlights a conflict of interest: on October 17, 2019, Tshabalala, as a member of the Bid Adjudication Committee (BAC), recommended Isidingo as the preferred bidder, and then proceeded to appoint the company in 2020 when she became the acting Municipal Manager (MM).

Although she declared her prior involvement with the BAC, the report states this constitutes a conflict of interest under the Municipal Systems Act 32 of



Additionally, Tshabalala didn't seek council approval for the contract extension, which ran for over a nine-month period, and she continued to renew the contract until February 28, 2023.

The tender's validity period of 90 days had also expired at the time of Isidingo's appointment, and an uncertified lease agreement submitted by Isidingo was accepted, even though two other service

providers were disqualified for failing to submit a compulsory certified lease agreement.

The SIU report concludes that the appointment of Isidingo constitutes irregular expenditure, and the contract extension amounts to unauthorised expenditure.

"Evidence reveals that the appointment of Isidingo by the MM for the provision of physical armed security awarded was irregular and unlawful and in contravention of Section 217 of the Constitution of South Africa," the report states, adding that the MM's conduct is "unacceptable, unethical, unlawful, (and) irregular".

The report also suggests that the NPA should consider instituting criminal charges against Tshabalala for contravening the Municipal Finance Management Act (MFMA), stating that the MM's conduct is a criminal offence in terms of the MFMA.

However, Journal News contacted the NPA spokesperson in the Free State, Mojalefa Senokotsoane, who clarified the NPA's mandate.

"Unfortunately, the NPA does not make arrests. Our mandate, as guided by the NPA Act and the Criminal Procedure Act, is to prosecute cases brought before the courts."

Senokotsoane stated that the NPA is "not in a position to comment on any matter until a suspect has been charged, arrested, processed, and has made their first appearance in court."

He advised that the appropriate law enforcement agency to engage is the South African Police Service's Directorate for Priority Crime Investigation (DPCI/Hawks), as they are "best placed to confirm whether there are any pending arrests".

## **UFS Bows to Student Demands**

he University of the Free State (UFS) has agreed to meet several demands made by protesting students, following days of unrest and disruptions across its campuses.

The decision comes after tense negotiations between student representatives and university management, centered on issues such as financial exclusions, accommodation shortages, and delayed allowances. The agreement aims to restore stability and ensure the resumption of academic activities.

This follows a week-long violent protest that left university buildings torched, infrastructure damaged, several students arrested, and others hospitalized. The unrest began at the institution's Qwaqwa campus before

spreading to the main campus in Bloemfontein.

The demonstrations erupted in response to the university's announcement that its new debt policy would take immediate effect. However, following negotiations, the University of the Free State (UFS) acceded to student demands and agreed to postpone the implementation of the policy for two years.

The policy, which had drawn widespread criticism, would have prevented students with outstanding fees from registering provisionally. After discussions on Wednesday, the university confirmed that indebted students will still be allowed to register in 2026, providing additional time before the new rule is enforced.

Under the agreement, the institution will only implement the policy in 2027, allowing continued dialogue between management and student leaders.

University spokesperson Lacea Loader said academic activities would resume in phases according to programme requirements, with faculty deans responsible for coordinating and communicating the return process to students.

While staff have started returning to the Bloemfontein and South campuses, the Qwaqwa campus remains closed as investigations into property damage and arson

A total of 23 students were arrested and charged with contravening the Criminal Matters Amendment Act and with public violence. They have appeared in court and were released on warning pending their next appear-

In the meantime, students will continue their studies through online learning.

## Pharmacies permitted to sell and prescribe ARVs

eputable and accredited pharmacists in South Africa have officially been given the green light to prescribe antiretroviral (ARV) medication, a move aimed at improving accessibility and reducing the country's high HIV infection rate.

The South African Pharmacy Council (SAPC), which regulates the pharmacy profession, has welcomed the Supreme Court of Appeal's decision upholding the legality, rationality, and necessity of the Pharmacist-Initiated Management of Antiretroviral Therapy (PIMART) pro-

When the SAPC was established in 1995, accredited pharmacists were permitted to provide limited services such as HIV testing, emergency contraception, pregnancy testing, urine analysis, sexual health advice, and occupational post-exposure HIV prophylaxis for healthcare

By 2000, antiretrovirals were introduced in the private sector for people living with HIV, but only medical specialists—mostly hospital-based—were authorised to

Later, the Nurse-Initiated Management of Antiretroviral Therapy (NIMART) programme expanded treatment access by allowing trained nurses to prescribe ARVs in

Despite these efforts, HIV infections continued to rise-from 5.7 million to 8.2 million by 2010. By the 2019/2020 financial year, the national ARV budget had exceeded R20 billion, underscoring the urgent need for broader treatment access.

In 2020, the Department of Health authorised nurses in private pharmacies to prescribe ARVs at pilot sites, provided they had completed NIMART training. This development paved the way for pharmacists to take a more active role in HIV care through PIMART.

The PIMART initiative enables specially trained pharmacists to prescribe first-line antiretroviral therapy to patients who test positive for HIV, and to refer complex cases to medical specialists.

On 9 October, the Supreme Court dismissed an appeal by the Independent Practitioners Association (IPA) that sought to block the implementation of PIMART.

"The ruling confirms what has been our long-held view-that PIMART is a necessary and competently designed intervention to support South Africa's fight against HIV and AIDS," said SAPC President Mogologo

He emphasised that only pharmacists who have re-

ceived specialised training will be authorised to provide

"PIMART will offer access to much-needed HIV prevention and treatment care, with the immediate benefit of improved quality of life and increased life expectancy for more people living with HIV and AIDS," Phasha add-

He further warned that delaying PIMART would hinder efforts to identify undiagnosed individuals and start them on treatment.

The government's national goal—to ensure that 95% of people living with HIV know their status, 95% of those are on treatment, and 95% of those on treatment achieve viral suppression—will be more attainable through PIMART's implementation.

"The SAPC, together with stakeholders and the Department of Health, will move swiftly to ensure that PI-MART-trained pharmacists join other primary healthcare practitioners in providing HIV and AIDS services," concluded Phasha.

Although no date has been confirmed for the full rollout, it is estimated that over the past five years—since PIMART was first proposed—about one million new HIV infections and 395,000 HIV-related deaths have occurred

## Police raid Brown Mogotsi's North West business premises

■ esterday the police raided the premises of businessman Brown Mogotsi in Seweding village in Mahikeng, North West.

National police spokesperson, Athlenda Mathe, said police went to Mogotsi's premises as part of an ongoing investigation that has already been discussed before the Ad hoc committee and the Madlanga commission.

Mogotsi, an alleged associate of embattled Police Minister Senzo Mchunu, has been widely accused of siphoning money from businessman Vusimuzi "Cat" Matlala to bankroll the ANC's ac-

He has been implicated in the alleged unlawful interference at the South African Police Service (SAPS). Mogotsi has been a central figure during the Madlanga Commission's early testimony, with multiple witnesses pointing to his proximity to high ranking SAPS officials, being an information peddler and his alleged role in corrupting the integrity of law enforcement.

Mogotsi's name featured prominently through WhatsApp messages at the Madlanga Commission which showed how he used his ties to the ANC to get money from criminals for his benefit. Some monies were used to fund ANC activities.

Last week, IOL reported that the ANC had dis-

tanced itself from allegations of organised criminal activity levelled against Mogotsi, stating that he was not a registered member of the party.

However, Mogotsi struck back, maintaining that his membership remains valid and that he can prove it.

"I am a member of the ANC and I shall remain a member, a volunteer of the African National Congress. That is the status," Mogotsi said in an interview with broadcaster Newzroom Afrika.

In contrast, Mbalula told journalists that Mogotsi's ANC membership had expired, meaning the North West businessman was no longer part of the movement.

Mogotsi rubbished the claims, accusing Mbalula of acting prematurely and relying on untested information presented to the Madlanga Commission of Inquiry.

"He is relying on messages presented to the commission. I thought as a secretary-general of the oldest movement on the continent, he would allow the rule which he mentioned, the audi alteram (partem principle, to state his side of the story)," said Mogotsi at the time.

He dismissed Mbalula's assertions as "immate-

Mogotsi added that he would not contest any decision by the ANC to terminate his membership.- IOL

## Over 16,000 Candidates in the Northern Cape to Sit for This Year's Matric Exams

total of 16,056 candidates have registered in the Northern Cape for this year's National Senior Certificate (NSC) examinations.

When the NSC examinations commence on Thursday, 23 October, 14 210 full-time candidates and 1 846 parttime candidates from the province will sit for this important examination. It concludes on 27 November.

In a statement, the Northern Cape Department of Education said it is fully prepared to administer the 2025

In 2024, the Northern Cape achieved a pass rate of 84,2%, representing an improvement of 18,2% over the past five years and up from 66% in 2020.

"The Class of 2025 now carries the responsibility of building on this achievement, with the aim of not only improving on last year's performance, but also exceed-

ing the national average," the department stated. The department has implemented a range of targeted interventions to support all learners, with particular focus on progressed and borderline candidates to maximise their potential.

eputy Minister in the Presidency, Nonceba Mhlauli, engaged students and stakeholders during the G20 TVET College Community Dialogue held at Motheo TVET College in Bloemfontein on Thursday.

The dialogue served as a platform for Motheo TVET students to discuss global issues and share their views on policy advocacy.

Mhlauli emphasised the importance of solidarity, equality, and sustainability among the youth, urging them to be vocal and intentional in building a more inclusive and sustainable future.

Driven by her passion for youth involvement in politics and policy development, Mhlauli provided insights into existing programmes aligned with G20 priorities and designed to empower young people. She engaged robustly with the student community, responding to their concerns and reflecting on her ongoing outreach work to promote public participation.

## Life imprison for two raped charges

25-year-old man was sentenced to life imprisonment for the rape of two minors in February 2022 at Manyatseng, Free State. The Ladybrand Regional Court convicted and sentenced Ntsikane Sani for the rape of two girls aged 11 and 13. Free State police spokesperson Warrant Officer Mmako Mophiring said the first victim was accosted outside her home while using the toilet. "The accused grabbed and forcefully dragged her from her home to a local dumping field, threatening to kill her with a knife in his possession, and raped her." In the second incident, the 13-year-old girl was walking home from school with a group of friends when she kidnapped by the accused.

The accused was found guilty in both cases and sentenced to life imprisonment for the first case and 15 years imprisonment for the second case.

## **ActionSA** wins its first by election in North West

The party now has a seat in the Ramotshere-Moiloa Local Municipality after it beat the African National Congress (ANC) by just two votes

ctionSA has won its first-ever by-election, five years after it was formed. The party now has a seat in the Ramot-

shere-Moiloa Local Municipality after it beat the African National Congress (ANC) by just two votes. The by-elections took place on Wednesday across six

wards in Gauteng, North West, Limpopo, Eastern Cape, and the Western Cape.

Moses Moumakwa is the new ward 7 councillor, replacing the ANC's Petrus Mokgatlhe, who vacated the seat after being fired by his party for ill-discipline. Ramotshere is an ANC stronghold, with the party

having won all of its 19 wards since 2006. Earlier this year, ActionSA merged with Forum 4 Service Delivery, which has a strong support base in some

North West municipalities. ActionSA national chairperson, Michael Beaumont, said the latest round of by-election results has been en-

couraging for the party's growth. "Results of last night's by-election demonstrate that ActionSA is one of the few parties in SA growing at the

expense of the ANC, at a time when we need to rescue a broken local government system." Meanwhile, the Patriotic Alliance (PA) making has made inroads, including a surprise victory in Soweto —

long considered an ANC stronghold. The PA's breakthrough came in Johannesburg's Ward 29, covering the older Soweto townships of Diepkloof

Notably, Noordgesig Primary School accounted for nearly 70% of the PA's votes. The ward became vacant

after the death of ANC councillor Brenda Dammie, 56, earlier in 2025 due to ill health.

PA candidate Ismael Steenkamp won the ward with 1,756 votes — just over 30% of the total. The ANC's share collapsed from about 40% in the 2024 provincial elections to 22%. The EFF rose to 16%, and ActionSA garnered nearly 10%. Smaller parties, including MK and Operation Dudula, polled poorly, with the latter earning just 3%.In the Western Cape, the PA secured a historic win in Ward 6 of Swellendam, taking 811 votes. The ANC dropped to 486, and the DA to 303. The winning PA candidate. Julian Alan Matthysen, is a former ANC councillor who reclaimed his seat under the PA banner.

Elsewhere, the ANC regained Ward 4 in the Langeberg Municipality's Happy Valley, Bonnievale, with 47% of the vote. The DA followed with 28%, and the PA came third with 21%. ANC candidate Daniël Baadijes, a former Freedom Front Plus member, was credited with the party's recovery in the area.

In the North West's Ramotshere Moiloa Municipality, ActionSA's Moses Moumakwa narrowly defeated ANC rival Ben Kabelo Malefo by two votes — 837 to 835. The EFF came third with 214 votes, and the PA had 123.

## **Two Orkney Men Die After Inhaling Toxic Sewer Fumes**




wo men died in Orkney in the North West earlier today after they seemingly inhaled toxic gasses while unblocking a sewer pipe.

## Two toddlers perish

in shack fire

... After their now-arrested mother left them with their eight year old sibling for hours

wo young children, aged one and three, died in a shack fire in Caleb Motshabi, Bloemfontein, on Monday, 13 October 2025. A third child, aged eight, managed to escape the blaze.

Police have opened a case of child neglect and culpable homicide. The children's mother appeared briefly in the Bloemfontein Magistrate's Court on Thursday, 16 October 2025.

According to reports, the 30-year-old mother allegedly left her three children alone in the shack at around 6 pm and returned four hours later to find it completely destroyed by fire.

The Department of Social Development revealed that 9,485 cases of deliberate child neglect and 595 cases of abandonment have been recorded in South

Free State MEC for Social Development, Mathabo Hlalele, expressed deep sorrow over the tragedy.

"We send our condolences to the family of the children who died in the fire. It is heartbreaking for such young lives to be lost in this manner. Our thoughts are with the family," said MEC Hlalele.

Free State Premier Magueen Letsoha-Mathae also voiced concern, recalling a similar incident in Reitz in May, where two siblings died in a shack fire.

"We must do better as parents, particularly mothers. We cannot continue losing our children in this manner." said Premier Letsoha-Mathae.

## Mchunu explains why he did not communicate with Masemola on disbandment of PKTT

uspended Police Minister Senzo Mchunu provided detailed insight into why he chose not to communicate directly with National Police Commissioner General Fannie Masemola regarding critical concerns about the Political Killings Task Team

In his testimony before Parliament's Ad Hoc Committee probing police corruption on Thursday, Mchunu revealed that numerous members of the PKTT had privately contacted him with serious grievances about how the unit was being managed.

"Many members of the PKTT sent me messages asking to meet privately to raise issues with how it was being run," he said.

Concerned about protecting the identities and safety of these officers, Mchunu explained he was reluctant to communicate these issues openly through conventional channels.

"I sensed something was wrong, and I wanted to protect the officers that approached me," he told the

He described the problems within the task team as involving sensitive human resource and operational issues that, if left unaddressed, could damage the integrity of investigations and undermine justice.

"The way they practice and handle matters has the potential — if not dealt with expeditiously — to damage the unit's reputation and ultimately defeat the

ends of justice," Mchunu said.

To address these challenges, he convened a meeting on November 21, 2024, with some individuals, during which they reviewed complaints and began mapping out solutions.

"We discussed issues, including personnel problems, and began allocating resources to address

these problems. I convinced them of the importance of engaging the National Commissioner on these matters," he said.

However, he stressed that engaging General Masemola took time to finalize the form and timing.

"Because we didn't discuss the nature of that engagement in detail, I was left to determine how to

proceed. It took some time before I was satisfied with the process," Mchunu explained.

He emphasized that his hesitancy to communicate directly with the National Commissioner was not a lack of trust but a concern for safeguarding those who had confided in him.

"Due to their safety, I was influenced not to go to the National Commissioner. It had nothing to do with trust." he said.

Mchunu detailed his process before issuing his directive dissolving the PKTT.

At the end of 2024, after reflecting on the unit's progress and challenges, he concluded that performance still fell short of his expectations.

He described spending time in his rural hometown reflecting deeply before committing to the decision.

He added that he drafted the directive dissolving the PKTT on December 31, 2024, repudiating suggestions that others authored the letter or "people

"I sat alone and wrote that letter myself. It reflected my assessment of the work and the issues," he

Mchunu also addressed efforts to ensure accountability and fairness for those officers who had raised complaints, including plans to establish a neutral inquiry mechanism to provide them with a safe platform to give evidence.

## The deadly cost of whistleblowing in South Africa

OUTH Africa's long history of wrongdoing spans from Willem Adriaan van der Stel's days of running → a corrupt trading monopoly to present-day South Africa. Van der Stel was the second Governor of the Cape Dutch Colony, from 1699 to his removal in 1707.

Whistleblowers have been at the core of exposing these instances of corruption.

Public whistleblowing was rare under apartheid (1948-1994). But with the transition to democracy, the reporting of wrongdoing increased. This can largely be attributed to a new constitution that caters for all the country's citizens, and new laws that reinforced their rights.

One such law is the Protected Disclosures Act No. 26 of 2000, amended by way of the Protected Disclosures Amendment Act No. 5 of 2017. The law was designed to protect individuals who expose perceived wrongdoing to an authority that has the capacity to remedy the wrongdoing.

Yet, it has offered inadequate protection. South African whistleblowers have been overwhelmingly subjected to reprisals – from murder to social, work-related, and legal retaliation.

Our academic expertise is concerned with exploring the experiences of whistleblowers in South Africa, and making meaning of their plight.

In a recently published paper we give an account of the stories of a selection of whistleblowers spanning five decades. We selected a few stories that have set precedents in South Africa.

These cases offer only a glimpse into the experiences of South African whistleblowers. But what is clear is that, by fulfilling their public duty, they place themselves at great personal risk.- IOL



## SANParks Hits R4-b Revenue Mark... For The First Time

outh African National Parks (SANParks) presented an overall positive overview of the entity's operational and financial performance for the past financial year

Addressing the Portfolio Committee on Fisheries, Forestry and the Environment, SANParks Chief Executive Officer, Hapiloe Sello, reported a 11 % increase in revenue from 3.67-billion to R4.1-billion in 2024/25. This is the first time that SANParks revenue exceeds the R4-billion revenue mark. Notably, 75% of this revenue was generated from commercial activities, underscoring the effectiveness of the organisation's commercial strategies.

Sello also drew attention to the fact that SANParks has a net cash balance of R2.7 -billion and maintains a positive solvency position with total assets exceeding total liabilities by a margin of R3.7-billion.

These results demonstrate that SANParks possesses strong financial health, underpinned by solid revenue growth, healthy liquidity, and a resilient balance sheet, confirming that it is a financially sound and well-managed institution.

SANParks also received an unqualified audit outcome for the past year, affirming the strength of its financial governance and management practices.

The entity continues to improve its internal controls, and these efforts have yielded positive results, as reflected in the Auditor-General's report.

According to Sello, the report highlighted areas of improvement, particularly in the quality of the Annual Financial Statements and in Supply Chain Management, where no material findings were identified, an improvement from the prior year. Work continues to strengthen the control environment, with optimism that this will bring further improvements in the coming period.

"On the operational front, SANParks achieved 86% of its performance targets – meeting 24 out of 28 goals. Notably, 18 of these targets that were met are also exceeded underscoring the organisation's commitment to excellence," said Sello.

He also emphasised that SANParks' exceptional financial and operational performance in the 2024/25 financial year demonstrates its unwavering commitment to conservation, sustainable development, and community empowerment.

"With a landmark revenue milestone, a robust financial position, and an impressive 86% achievement of performance targets, SANParks continues to strengthen its role as a cornerstone of South Africa's environmental and socio-economic landscape," he said.

These accomplishments reflect the dedication of our team and stakeholders' efforts to sustainably manage our national parks for future generations while fostering inclusive growth and transformation.

## Warning about Walmart prices in South Africa



ormer Shoprite chief executive, Whitey Basson,
warned that it would be difficult for Walmart to
beat Checkers and Pick n Pay's prices.

stores are set to open before the end of the year, with official opening dates to be announced in October," McLay said.

"Every rand matters when it comes to price. This balance of quality and everyday low prices enables us to build customer trust," said Massmart CEO Miles Van Rensburg.

When Walmart enters a new country, it focuses on low prices, supply chain mastery, and local adaptation to gain market share.

Basson, told Netwerk24 it will not be easy for Walmart to undercut large retailers like Checkers and Pick n Pay.

He explained that you need high volumes to re-

duce prices. As a new entrant, Walmart will not have the same volumes as the large retailers.

Basson said it is good for the South African retail

market to get new blood in the form of Walmart's imminent launch.

"It is great for the young professionals at Shoprite to face real competition from Walmart, especially

as Pick in Pay was struggling," he said.

"Walmart will implement the best practices of the retail sector in South Africa. This is good for the

the retail sector in South Africa. This is good for the sector," he said.

However, Basson cautioned against people ex-

pecting Walmart to offer better prices than the existing players.

"Between Shoprite, Pick n Pay, and Food Lover's

Market, the price of food is very low compared to international standards," he said.

"Our profit margins are half what I have seen in Europe and the United States. This should not be the case."

Basson added that it would not be easy for Walmart to take on established food retailers in South Africa. "The young professionals at Shoprite are skilled and hardworking, and are using technology to their benefit." he said.

### Kganyago warns surging global debt threatens financial stability

The Financial Stability Board has elevated debt concerns to a top-tier issue, says SA Reserve Bank governor



A Reserve Bank governor Lesetja Kganyago warned on Wednesday that rising global debt poses a risk to financial stability.

The Financial Stability Board, which reports to the G20, has elevated debt concerns to a top-tier issue, Kganyago said on the sidelines of the IMF and World

Bank annual meetings in Washington.

According to IMF projections, global public debt is expected to surpass 100% of global output by 2029, with the organisation cautioning that under an "adverse but plausible" scenario, debt could reach 123% of GDP by the end of the current decade — levels not seen since the aftermath of World War 2.

"The issue of debt is not an emerging market problem," Kganyago said.

While African nations face liquidity and fiscal challenges related to debt, "the debt is now a global issue, and it is a problem in the developed economies as well", he added.

Debt concerns are expected to be a focus of the G20 meeting of finance ministers and central bankers, which ends on Thursday.

It is expected to issue a declaration addressing global debt as SA prepares to hand over its presidency to the US.

Kganyago said SA has focused on continuity during its presidency, including elevating cross-border payments within the G20 framework.

Civil society groups have criticised SA for slow progress on debt sustainability during its leadership. In a

letter signed by 165 organisations, including Eurodad and the Malala Fund, campaigners called for deeper debt relief and reforms to global restructuring processes

IMF fiscal chief Vitor Gaspar warned of a potential fiscal-financial doom loop triggered by sustained borrowing and high interest rates, urging governments to rebuild buffers.

Kganyago said discussions were ongoing regarding how the incoming US presidency would continue the African agenda on debt and financing costs.

"Tomorrow, at the end of the meeting, we will know exactly what they are taking off, because in their accepting the chair, then they will state what they are carrying from the previous presidency and what they are bringing in their presidency." he said.

Highlighting achievements under SA's leadership, Kganyago pointed to the elevation of cross-border payments within the G20 framework.

"It had proved to be a very good proposition, because that is something that everybody had signed off on, including the US, which is a very important participant in that cross-border payment committee," he said.\*This article was first published by Business Day

Meanwhile, the launch of the hub is expected to

"I have gained knowledge of what my business requires to be able to do, and also market exposure. I have been able to understand what a businessman is and what's needed from me, and it has also given me the opportunity to have resources," says one local entrepreneur.

"One of the things that I am getting here is the knowledge of how to navigate the business here in Mahikeng because it's a tech hub as well. I have a tech business, so it's helping me with resources," says another local entrepreneur. **SABCNews**



his Saturday, the tranquil town of Harrismith is set to transform into a testing ground of grit, endurance, and sheer willpower for the 103rd staging of its legendary annual Mountain Race.

Far from a standard weekend jog, this trail race competition has earned the audacious - yet, by all accounts, accurate - title of the 'toughest race in the world' by its organisers. It is an assertion that speaks volumes about the punishing terrain awaiting the hundreds of athletes ready to tackle the infamous slopes of the Platberg mountain.

The event, steeped in over a century of history, offers three distinct categories this year, catering to various levels of masochistic enthusiasm. The bedrock of the competition is the 15km Mountain Race, a storied event that has been an annual fixture for an astonishing 102 years, tracing its origins all the way back to 1922.

For those seeking an even more profound challenge, the 30km Trail Run pushes the limits of ultra-endurance athletes, a category that is now entering its seventh year. But the 2025 event marks a significant evolution, as a new 10km trail is incorporated for the first time.

Vusi Mazibuko, the race's Marketing Manager, and a Harrismith native who works as an engineer for Eskom in Cape Town, highlights the lineage of the competition and the excitement around its expansion.

"The main race, the Mountain Race, which is 15km, has been run for 102 years since 1922 and the 30km Trail Run has been run for 7 years, while the mini mountain trail run, which is 10 km, will be run for the first time this year," Mazibuko explains.

The incorporation of the 10km distance, though new, is expected to draw a significant number of participants, adding to the electrifying atmosphere.

"We are hoping to have around 500 runners for the mini race. For the Trail Race, which is much tougher, we are expecting around 200 entrants and for the main race we are expecting 600 to 800 runners," add-

ed Mazibuko. But the true legend of the Harrismith Mountain Race lies in the challenge itself. This is a raw, unforgiving encounter with the natural world. The Platberg's ascent is characterised by a brutal combination of altitude gain and treacherous footing - making it a true test of physical and mental fortitude.

Mazibuko pulls no punches when describing the obstacles facing the runners, giving context to the race's self-declared title.

"There is no (actual) road; there are big rocks and there is also a one-man pass where runners can't run past each other. You literally must run behind another runner with no opportunity to go past them." he adds.

This notorious "one-man pass" forces runners into a single-file procession, eliminating any possibility of strategic overtaking. The organisers' confidence in calling it the 'toughest in the world' is not merely promotional hyperbole, but a testament to the decades of sweat, tears. and triumph etched into the mountain's slopes.

As the sun rises over Harrismith this Saturday, the thousands of entrants won't just be racing against a clock or against each other; they will be taking on a living, breathing challenge - a mountain that demands respect, resilience, and an unwavering spirit.

This year's edition of the Mountain Race promises to be a spectacular display of human endurance, reminding both competitors and spectators alike that true glory is often found on the most difficult path.

All races will commence from Harrismith Primary School sports grounds, with the first race starting at 08:00. A prize giving ceremony will take place after all races are completed with cash prizes also on offer to cap off another pending successful Mountain Race in the easter Free State.

## **Qualification Drought**

wave of relief and euphoria swept across South Africa last night as Bafana Bafana finally booked their place at the 2026 FIFA World Cup in the USA, Canada, and Mexico.

The 3-0 victory over Rwanda on the final matchday of the CAF qualifiers in Mbombela was the culminating moment of a campaign that broke a 23-year drought since the team last earned legitimate World Cup qualification through competition.

While the nation had proudly hosted the 2010 tournament, their last successful run through the gruelling African qualifying channels dated back to 2002 - making this achievement under coach Hugo Broos a profoundly significant milestone that reconnects a new generation of players and fans to the global stage.

The journey through Group C, which featured powerhouses like Nigeria and determined challengers such as Benin, was a rollercoaster of highs and near-disasters. The campaign started with cautious optimism, and Bafana Bafana often showed the tactical discipline instilled by the Belgian coach.

However, the path was dramatically complicated by an administrative oversight involving star midfielder Teboho Mokoena.

It was belatedly discovered that Mokoena had played in a key qualifier against Lesotho while suspended for accumulated yellow cards. The resulting FIFA disciplinary ruling was a devastating setback as South Africa was subsequently handed a 3-0 forfeit defeat, overturning an initial 2-0 win and stripping them of vital points.

This single technicality plunged the team from a comfortable first place to a precarious second, forcing them to rely not only on their final match but also on other results in the group.

The pressure coming from these permutations on the final matchday was almost unbearable, putting the national team in a situation where they needed a win against Rwanda and, crucially, required Group C rivals Nigeria to defeat Benin in a simultaneous fixture. The players, led by coach Broos, responded with a dominant performance following a disheartening 0-0 stalemate against Zimbabwe last Friday.

The early opening goal from Thalente Mbatha in the 5th minute, followed by a composed strike from Oswin Appollis, provided the necessary confidence boost. Evidence Makgopa sealed the 3-0 victory in the 71st minute, but the final confirmation was delayed, with the entire nation anxiously awaiting the result from the other crucial encounter.

While closely following the positive developments in Nigeria's concurrent fixture, News of the Super Eagles' decisive 4-0 win over Benin arrived shortly after the final whistle, confirming Bafana Bafana as Group C winners thus granting them automatic passage to the global showpiece next year.

This achievement marks only the third time South Africa has legitimately qualified for the World Cup since their readmission to international football in

The first historic feat came in 1997 when they secured a spot for the 1998 World Cup in France under the tutelage of French coach Philippe Troussier, topping a group that included Congo, DR Congo, and Zam-

Queiroz, Bafana Bafana earned their second consecutive qualification for the 2002 World Cup in South Korea and Japan, again finishing top of their group ahead of nations like Zimbabwe and Burkina Faso.

Four years later, under Portuguese coach Carlos

The 2026 campaign now completes a trio of qualification successes built on merit - distinguishing it from the automatic entry they enjoyed as hosts of the 2010

For coach Hugo Broos, who took responsibility for the administrative drama while maintaining faith in his squad, this qualification is the crowning achievement of a long-term building project. His disciplined approach, which saw him integrate a fresh generation of players, has restored Bafana Bafana's stature and reignited a passionate football culture that had long felt disconnected from the international pinnacle.

The drought is over, and the country looks forward to watching its national team compete against the world's elite in North America.

#### Molokwane Resigns from World Netball Board

n a significant development for the governance of international netball, World Netball (WN) confirmed yesterday, through a media statement, that Cecilia Molokwane has resigned from her position as a director on its board with immediate effect.

This announcement by the global netball body was coupled with a clarification regarding the serious and ongoing disciplinary process involving Molokwane.

She is accused of misusing Netball South Africa's (NSA) funds and resources, including funds related to the World Cup. Additionally, Molokwane is accused of bullying and intimidating staff members - allegations she has strongly denied.

WN further stated that its internal investigation has concluded, and that its findings have been forwarded to an independent arbitration service, which is in the process of convening a full disciplinary hearing to address the matters raised.

Molokwane also remains suspended from all netball activity while the hearing proceeds, to ensure that she cannot participate in any aspect of the sport as the arbitration service works to adjudicate the case.

She claims to be a victim of a smear campaign that is aimed at keeping her from contesting NSA elections.

"This is nothing more than a calculated plot to keep me out of the elections," she declared at press conference she convened in Polokwane, Limpopo, yesterday.

"I've been silent for too long, but silence will not defend the truth. I called this press conference to fight for fairness and transparency. I deliberately waited for the Telkom Netball League and the Under-21 World Cup to end, because I didn't want to harm the sport I love," added Molokwane.

WN has also clarified its position on NSA, confirming that the national body has not been suspended as a member of the international federation. This separation ensures that NSA's standing and involvement in global netball remain unaffected by the proceedings against one of its prominent former leaders.

To safeguard the integrity and confidentiality of the disciplinary hearing, which is being coned in line with WN's disciplinary

The NEC congratulated the South U20 Men's National team, Amajita, after they made history by becoming the first South African National team to win two matches at a FIFA World Cup. Coach Raymond Mdaka's team captured the imagination of the public as they flew the South African flag high at the FIFA Under-20 men's World Cup in Chile recently. It was also the first time since 2009 in Egypt (under Serame Letsoaka) that Amajita have progressed to the Round of 16 where they lost 2-1 to Ghana after extra time.

The NEC then went to support Bafana Bafana at the Mbombela Stadium after the conclusion of the meeting and were on hand to witness coach Hugo Broos' charges qualify for next year's 2026 FIFA World Cup to be held in the United States of America, Canada and Mexico in June 2025. Bafana Bafana beat Rwanda 3-0 to qualify for the global showpiece. - SAFA
